- New Business
 - Discussed placing the Corporate meeting minutes on the website in a timely manner. If we waited until the minutes were accepted, the Memorial Day meeting minutes would not be available on the website until after Labor Day. The Board agreed that the Corporate meeting minutes can be posted to the website prior to being accepted provided that the minutes are noted as “unaccepted”.
 - Discussed where to locate the LGPOA's copier next year. It is currently kept at Kim Smith's house. There is room at the Township Community Hall per discussions between Roger Cary and Carol Majewski. Another alternative is to have the copier located at a LGPOA member's house. Board members should give the topic some thought prior to the next Board meeting and be prepared to finalize the storage location.
 - Debated offering to pay for the July 4th flares passed out to residents. The flares were supplied by Ringley's Hardware at no cost to residents. After discussion the Board voted to pay for the cost of the flares and none were opposed.
 - Discussed the printing costs for the directory. The Cleaver can print the directory for an estimated price of \$451. Alternatively, the directory could be printed using the LGPOA's copier. Kim Smith will provide business case data in support of using the LGPOA copier. Several Board members offered to assist in printing if needed. Due to time constraints, this decision will need to be “discussed” via email for a final decision.
