- g. **Lake Quality**: LG Snail Issue. Early warm can cause issues with this and is not a threat. Dennis will report Lake lowering issue.

- m. Guest Speaker: Dennis Zimmerman www.lincolntwp.com. 2023 property taxes assessed value and tax value will increase. Due to covid and increasing costs. By about 5%. Typical increases are 2-3%. State mandate and state wide. Spongy Moth spray kill rate of 70-80%. Same as last year. If you feel you have lots of moths, let township know. Every 12-13 years there is a cycle. Will die down and then will recycle. Bacteria will not harm plants or animals or people. New Plant notices, but not detrimental to water quality and will go away once water warms up. Drain commission Legal Lake Level in Bertha Lake. Legal lake levels set by circuit court judge. If you want to change anything about that you need to go to the courts. Lake Levels (see Dennis's report). Levels will change. Shouldn't worry about it, but keep an eye on arbor. Spent money on new fire truck. Pagers and charges for all employees. Handicap ramp is being rebuild. Basement floor is being repaired. 3 new township computers. Trash pick up – fuel surcharge on trach pickup. No change to trash pickup. 1st road grinding was last Monday, next is June 28. Parks committee Carol has been approved to create committees to look over the parks and see what needs those parks have and will have \$10,000 per park for those improvements. Lake Quality / Testing. Samples have been pulled phosphates and oxygen and temp profiles. Late summer phosphate test. Clarity, oxygen, temperature is done about every 2 weeks. Question: Boat Launch area for sale. DNR could buy to expand property. Hamlin Field was brought up ... lots of discussion about what to do and what could be done and why nothing as been done to improve the area.

an application on the website to have submissions for donations and vote on Labor Day meeting. Need to disucss out how the money gets distributed. How much money do we want to earmark for the events and then open applications. Motion Application process to receive funds from LGPOA. Pam Cristoff 1st. Rolf 2nd. Motion passed. 2nd Part LGPOA fundraisers profit – 50 goes to general fund 50 goes to community giveback. Karen Vargas 1st and Sheri Frader 2nd. Motion passed. Rolf made a motion to leave the board the authority to decide on where to send the money based on applications. John 2nd. Motion passed.
