Swiss will be on board for a possible spaghetti dinner night before and breakfast morning of. They are willing to be part of events in a bigger way. We will not have the food truck. Will have events in 2024 on July 6th. Flares were a huge it. We will advertise more for next year and have the Depot and maybe Swiss have them for sale as well. Try to delegate someone to man flares at the run registration - and check members for free flares. Also let everyone know that the siren will blow at 10pm since those art the far end of the lake cannot hear it.

Big question – what does the Igpoa do for its members. We have focused on donating to the children's events and not really "giving back" to the members. We are slowing turning that around and think that the Spring "welcome back" for members only party will put us on that track with current and future members.
