- i. Township Liaison: Dennis sent Troy a "important" letter. DNR adopted findings from Wakeboard study. DNR recommendations is that any lake that is not 15' deep and 500' wide cannot support a wakeboard upsets the ecosystem. All we can do is watch what happens. Put a little blurb about the wakeboard info with link in the website.

- k. **Fish Committee**: 2017 Fish survey was done last. Looking at those reports and was going to check with conservation officer about what fish are being caught. We can vote to change size limit on Pike. Bass is 14" limit. Bluegill is abundant and get dwarfed because so many of them are present. Lake management putting channel cats would help with population or we can pick a fish and add them to the lake. We'd have to pay for this from the fish fund. What is the recommendation to keep a good fishery on LG? Bring this up at General Membership meeting to get members input.
- 4. **Old Business**: By Laws changing the description of memberships and associate memberships. LGPOA was originally created for care of the lake. Since this is no longer accurate and it is to take care of our community on and around our lakes. There is nothing that we vote on that has any sort of tax effect or anything that will change legislation. It is for the greater community good. Our Mission Statement needs to be re-written. Rick made a motion to change article VI paragraph 1 to allow 2 votes for every parcel within ½ mile of Shingle Lake and LG. Allow Associate membership be any parcel within Lincoln township. This will open campground. Erica 2<sup>nd</sup> the motion. Motion passed.
